Coos Soil and Water Conservation District Regular Meeting Minutes-February 23, 2017 Approved (March 23, 2017)

Regular monthly meeting was called to order at 7:15 PM

Board members present:, Mark Villers, Adela Villers, Ernie Newton, , Dan Pierce, Chuck Steffensmeier

Guests present: John Fandel (CPA), Christopher Claire (ODFW), Eric Moeggenburg (NRCS)

7:15PM Meeting called to order. Mark was slightly late, having come from the recently completed Wood Creek small grant project site

7:20PM Chuck Steffensmeier – Chuck reads and signs the Oath of Office – (after elections newly elected members must be sworn in)

7:25PM January DRAFT meeting minutes - Accepted with corrections: (Roger Dahl's name misspelled).

7:25PM Ernie moved to approve January minutes. Adela seconded the motion. All in favor; motion passed.

7:26PM Treasurer's Report – John said we are doing very well managing the budget. District Operations fund is about 67%, and SOW is about 55%. We are currently 59% of the way through the year, so we are fairly ontarget with regards to our budget.

• Mark talked about the small grants - \$70,000 left in the pot, few applications received this biennium.

7:35PM Discussion about how small grant funding works – Caley explained that the District only gets about \$600 in cash off each one, therefore they really are mainly a community service that we offer, since we typically end up spending more than we make back off of each one in administrative allowance.

7:40PM Dan moved to approve the Treasurer's Report. Ernie seconded the motion. All in favor, motion approved.

7:42PM Caley mentioned the newsletter, which was extremely productive this year

- Lots of phone calls from landowners
- 4 site visits completed so far
- 2 more to be scheduled
- Multiple grants resulting from landowner contacts made via newsletter response

7:52PM Projects committee meeting – TBA

- Chuck suggested we do an electronic roundtable to avoid having to schedule another meeting.
- Mark agreed it would be easier for him too.
- Caley said she would send around draft project maps and photos with a rough outline budget and basic explanation for each.

- Discussion of pros and cons of April submittal of Melissa King grant
- 5-6 small grants
- Caley slightly overbooked with projects

8:23PM Mark asked Eric to chime in on farm succession tours. Eric said he's recently been to a presentation on farm succession and that it's a very important topic for NRCS.

- It's a big issue right now as the average age of most farmers is 58 and some don't have children to pass their land onto.
- It's also really expensive to buy land these days so hard for young farmers to start out
- A trend of companies and corporations buying up land and leasing it out to tenants.
- John said that it's a very complicated issue legally, and you can't forget the human factor when it comes to formulating a plan for these types of family/land/succession scenarios.

8:35PM Rushal Sedlemeyer – work study / volunteer

- Volunteer forms template language from employee handbook
- John Fandel volunteers have to be covered by worker's comp insurance.
- SDAO should have template form.
- Need to call and make sure policy still covers one volunteer.

- Winding down on killing elk this time of year/damage tags/landowner preference still available
- Ernie asked about damage tags for turkeys causing a nuisance outside his work. Chuck wanted to know if you can live trap turkeys. Chris said to talk to Stuart Love or John McLoughlin about specifics.
- Finished flying/looking for elk; Tioga numbers look good but not seeing a lot of elk while flying over. This could be because Elk may be up in timber due to all the rain and bad weather
- Planting projects recently completed with Caley the auger was extremely helpful planting in the hard clay soils on Offield.
- Steelhead spawning; hatchery vs wild fish
- Currently collecting brood-stock for hatchery: Need volunteer donation fish/ still 30 individuals short
- Hatchet creek slide / fish kill
