Coos Soil and Water Conservation District Regular Meeting Minutes-May 23rd, 2019 (Approved June 27, 2019)

7:07PM Regular monthly meeting was called to order by Chairman Mark Villers

Mark asked if we needed introductions for any newer folks. Modena and Michael Clary had not met. Mark asked if anyone had any comments or corrections on the April minutes. No one had any edits.

7:10 PM Adela moved to approve the April minutes; Ernie seconded the motion, all approved. Motion Passed.

7:15PM Treasurer's Report:

John Fandel was not in attendance, but Caley reported that several items had been corrected. Also, the Scope of Work Fund was not as underspent as previously thought, due to the DEQ319 grant match having not been deducted from SOW monitoring capacity funds. We are closer on track to finishing the year with a zero balance, but with less room in the budget for extra expenditures such as the newsletter mailing. Caley said that when she gets the new corrected Finance Report, she will be better able to judge whether we can afford to mail the newsletter or wait until the next Fiscal Year.

7:25 PM New Hire Update: Mark had not had time to interview Kayla Rickford yet.

7:27 PM Ag Water Quality Compliance Case Update: Nick Thomas was given a notice of non-compliance and will be required to replant 1500 trees and shrubs on the riverbank where he had previously removed the vegetation. Caley had suggested that he contract the Coos WA planting crew directly to do the planting work, and has offered to help arrange a visit with Dave Nelson to provide a quote.

7:30 PM – 8:15 PM District Funding Presentation:

8:17 PM Continued discussion from last meeting on process of appointing new directors. Mark brought up the zone boundaries issue again, regarding the Director Zones 4 and 5. Caley reported that she had asked Eric Nusbaum about the process to adjust zone boundaries and he had indicated that there was a process to go through to do this. However, Eric was unable to attend the May Board meeting to explain further. Caley suggested that since the other interested director has not attended the last several meetings, that we could go ahead and appoint Mike to the Zone 4 Director position and still plan to address zone boundary lines as we move forward into the new fiscal year.

8:23 PM Moved to appoint Michael Clary to be director of Zone 4. Charlie seconded the motion; all approved, motion passed.

8:25 PM Mark Villers swears in Mike Clary. Mike takes the Oath of Office and signs the Oath of Office form. Caley will send the form to Sandra Hiatt to be filed on record with ODA. Mike will have to officially run for his position in the next election cycle.

8:30PM Coos SWCD staff Report

- -Review and discussion of Johnson Creek Stream Crossing OWEB Small Grant Application
- -Project was previously mentioned at the last board meeting but the application had not yet been developed
- -Project involves a fairly straightforward stream crossing to replace a collapsing culvert which has been deteriorating for several years.
